I am delighted to share La Crosse Community Foundation's 2021 Annual Impact Report to celebrate the generosity of our community's philanthropic caregivers and the great work of our region's nonprofit organizations that you helped make possible.

Last year's annual impact report showcased how our community came together to support each other through the COVID-19 pandemic crisis. This year's report is all about how our community is recovering and looking ahead. **STEWARDSHIP:** We upgraded our technology and financial systems to improve the donor experience, including launching a new online portal for our fundholders to have 24/7 access to fund information.



# FEATURED GRANT STORIES

La Crosse Community Foundation is comprised primarily of endowed funds; an intentional strategy that ensures we're around to respond to community needs forever. In 2021, the foundation awarded over \$4,000,000 in grants for the second year in a row. And because of the power of endowed funds, we distribute more in grants annually than we receive in donations, and our assets continue to grow. We were made for these times, and all times as our funds are built to support community needs regardless of market conditions.

## **EDUCATION & SCHOLARSHIP**

Forming Great Futures

**Western Technical College Foundation** is awarded \$8,000 annually to support the La Crosse Community Foundation Equity in Education Scholarship program. In 2021, eight students who either did not qualify for federal student loans or are non-traditional students received scholarships. One recipient wrote the following:

Dear La Crosse Community Foundation, I am writing this note to thank you for endowing me with your #1000 scholarship for equity in education. I am humbled and honored to be the recipient of this award. To tell you a bit about myself, I am Puerto Rican, and my second language is English. I am also a disabled veteran who is driven to self-realization and a relentless pursuit of knowledge. Though my current full-time job is in healthcare, I have always had a special interest in construction. when the opportunity presented itself, I decided to pursue a technical diploma in Building Construction and Cabinetmaking at Western Technical College, and I plan to graduate in April 2022. Although I will continue to work in the healthcare field, my goal is to find a reputable construction or cabinetmaking company to assist on a part-time basis. I have found this pursuit personally rewarding, enjoyable, and almost therapeutic. This scholarship will be used to relieve a portion of my student loans, and I intend to return the good karma. Islands of Brilliance was awarded a \$2,000 grant to support their Mobile Sandbox program. Islands of Brilliance is a Milwaukee-based nonprofit dedicated to providing experiential learning and workforce development opportunities to autistic youth and young adults. The grant will support their expansion work into La Crosse County.



## West Salem School District

received a \$5,000 grant to support bringing in motivational speaker Joe Beckman to present to students and families about creating a culture for human connection. His presentation was part of a larger district initiative to improve mental health.

**The Privilege Institute** received a \$5,000 grant from the June Kjome Justice and Peace Fund in 2021 to sponsor the local White Privilege Symposium. Community members gathered for the two-day conference to hear speakers such as Debby Irving, author of Waking Up White; rapper and activist Jasiri X; economist, environmentalist, and writer Winona LaDuke; and more. Local youth were also engaged in a Youth Action Project as part of the symposium.

## La Crosse Area Family YMCA

was awarded a \$5,426 grant from the Mary Grace Sieber Fund to support their new No Boundaries Summer Camp, a community-based program that promotes inclusion and awareness of individuals with disabilities. The summer camp was held at the Y's Teen Center, and included a variety of activities like gymnastics, swimming, outdoor recreation, arts and crafts, music, and more. The Y also partnered with the North American Squirrel Association to provide pontoon rides, fishing, kayaking, and more to campers.

## AVCAP Corporation and the La Crosse Composite Squadron of the Civil Air Patrol collaborated in 2021 to create the region's first dedicated drone search and rescue team. A \$3,000 grant was awarded from the Community Giving Fund to purchase laptops with graphic processing units that produce fast visual data from drones. Comprised of about a dozen youth, adult, and senior technicians and pilots, the team is available to help local fire departments, emergency management departments, and law enforcement agencies respond to a range of emergencies.


**Safe Families for Children** was awarded a \$40,000 grant from the Jean Gitz Bassett Fund, Rudy and Jean Schnurrer Fund, Norman L. Gillette, Sr. Family Fund, Robert & Eleanor Franke Charitable Fund, and David R. Morrison Family Fund. Safe Families started a La Crosse chapter in 2020 to surround families in crisis with a caring, compassionate community. They seek to prevent children from experiencing neglect or abuse by providing them with a safe, stable, temporary home while the crisis is resolved. Keeping families intact is their goal, and they recruit local families to open their homes and lives to children whose families need short-term support.



**La Crosse Lighthouse**, the area's first peer-run respite for folks experiencing substance use disorder, opened its doors in fall of 2021. A \$7,000 grant helped them purchase the final items needed in preparation for their grand opening, such as bed linens, towels, cleaning supplies, toiletries, and more. The Lighthouse is open to anyone 18 years and older who is looking to begin the process of recovery.



Workforce Connections was awarded a \$25,000 grant from the Robert & Eleanor Franke Charitable Fund and Bob & Jean Mark Family Fund to support their transportation assistance program. This program assists individuals and families at or below the ALICE (asset limited, income constrained, employed) threshold with funds to offset hardships associated with transportation needs, such as: vehicle repairs, tires, oil changes, and maintenance.



La Crosse Jail Ministry was awarded nearly \$9,000 in unrestricted funding in 2021. The Jail Ministry provides an opportunity and environment for inmates to awaken, renew, and stimulate their spiritual life, thereby promoting behavioral change, social reintegration, and personal wellbeing. The Jail Ministry's chaplain is skilled in providing spiritual support to followers of many world religions. Foundation funds that supported them include the William & Cynthia Berg Family Fund, Robert & Eleanor Franke Charitable Fund, Audrey and Donald Medinger Family Fund, Paque Family Fund, and St. Paul's Lutheran Church of La Crosse Legacy Funds.

Catholic Charities launched Operation Allies Welcome in 2021 to support over 13,000 refugees from Afghanistan at Fort McCoy. They coordinated volunteers, purchased supplies, and helped people through their resettlement process. Four foundation donor advised funds provided nearly \$7,000 to support this work, including The Covenant Fund, Guentner-Froegel Family Fund, Richard H. Masrud Memorial Fund, and Kurt & Julie Schroeder Family Fund.

## **Coulee Region Meow Mission** received a grant from the Carol and Duane Taebel Family Fund to support their work in humanely decreasing the number of free-roaming cats through a trap/neuter/vaccine/ return program.

## For Independent Hmong Farmers was

awarded a \$6,000 grant from the La Crosse Area Emergency Response Fund to offset pandemicrelated financial losses for 15 Hmong farmer vendors.



## John Bosshard Memorial Library in Bangor received a grant

to support needed updates from the Bramschreiber Family Fund in Memory of Karl Bramschreiber, a donor advised fund.

**La Crosse Concert Band** received over \$2,400 in grants from the Ella F. Ambrosius Fund and the La Crosse Area Emergency Response Fund in 2021 to support their free Wednesday night concerts in Riverside Park each June and July. Part of the funding was used to purchase supplies like sanitizing stations to make concerts more COVID-safe. The supplies were shared with Moon Tunes and La Crosse Jazz Orchestra.

## Ridge History Park

received an anonymous \$500 grant from a donor advised fund to support their operations. The history park includes the Little Middle Ridge Grade School and Cavadini's gas station, and hosts a free concert series the second Sunday of each month from May through October.









## Mississippi Valley Conservancy was awarded

a \$20,000 grant to support their Naturehood Connections program. This program was created to improve their La Crosse County nature preserves by nurturing a sense of connection, responsibility, and ownership in the families that frequent them. Three nature preserves host a rotating equipment toolbox that includes educational supplies, kids' activities, and tools for habitat restoration. Over 35 acres of invasive brush was cleared, millions of prairie seeds collected, and several pounds of litter removed as a result of this grant.

## **GROW** received a

\$20,000 grant to support their work connecting children to healthy food and nature through organic school gardens and farm visits. GROW has gardens at five local schools, and their garden educators visit classrooms several times each year to provide garden produce taste tests, recipe demonstrations, and environmental lessons about pollination, composting, and more.

# EQUITABLE GRANTMAKING FOR THESE TIMES

Before I started working on the "grant-making" side of grants, I was a grant *writer* for years. One of the most frustrating parts of writing grants was how difficult and nerve-wracking it always was to talk to funders. Why? They had all the power. Funders were nearly always hard to reach, unwilling to review proposals, and sometimes even denied access to apply for eligible projects because they didn't "think" their board would approve it. And forget about post-submittal support like opportunities to respond to guestions and helpful feedback after a denial.

When I started overseeing the competitive grant program here in 2018, movements like "Trust Based Philanthropy" and "Equitable Grantmaking" had just started percolating around the country in grantmaker circles. They call on funders to shift power, advance equity, and build mutually accountable relationships. That sounded like a dream. And it was about way more than just making it easier for people to apply.

Our area of the country fosters some of the deepest disparities in the nation for health and educational outcomes across race. Most of the social issues our local nonprofits address are rooted in various forms of oppression. And because we want to help create social change here, we need to make our grantmaking program less burdensome and do a better job reaching marginalized communities and the nonprofits serving them.

Building equity into our grant program means creating new pathways to funding to help ensure applicants have the tools needed to succeed, and without barriers. We want our application process to be accessible, supportive, and responsive. A stark difference from what I had experienced before.

We have much work to do, and are certainly not experts, yet we are excited to share some of the improvements we've started with:

## ENHANCED GRANTEE SUPPORT: Applicants can access

foundation staff for one-on-one technical support with both grant writing and understanding nonprofit compliance and finances. We also launched the Nonprofit Resource Center in 2021 with a board matching program, nonprofit health assessment tool, training opportunities, vendor list, and more.

COMMUNITY REPRESENTATION: We strive to fill our grant committee with people representative of the community and include the voices of folks who have a wide variety of experiences. We've increased our diversity on the grant committee by forty percent.

**OPPORTUNITY TO EXPLAIN:** After grants are submitted, if the grant committee has questions about a request, nonprofits have an opportunity to explain before decisions are made. This process helps avoid denials based on a lack of understanding.

FAST TURNAROUND: Grant decisions are made one month after each quarterly grant deadline, and grant checks are paid in full within a week of decisions being made.

UNRESTRICTED SUPPORT: We award project-based grants and grants for general operating costs, and will award up to three years of support.

FOLLOW-UP INTERVIEWS: Grantees can either write their required follow-up report, or complete it interview-style with foundation staff.


This list is just the beginning work in our goal of grantmaking through an equity lens, and we are open to feedback about how we can do better. Another idea we're currently exploring



is offering applicants the option of responding to grant questions with video instead of narrative writing.

We never can predict what community needs will bubble up with the most urgency at any given time. We can, however, stay committed to partnering with local nonprofits and using local data to ensure the help we have to offer is the help our community wants and needs. That way, we can hope to be beneficial in "these times" and always.

## DONOR ADVISED FUNDS



\$960,827 was awarded in grants from donor advised funds in 2021

Donor advised funds are the most flexible fund type, allowing fund advisors the ability to endow or spend down, to choose grant recipients anywhere in the world, and include the input from others in the grant-making process. Our donor advisors benefit from customized learning opportunities, including nonprofit tours, and can access foundation staff for information about where their dollars will make the biggest community impact. A donor advised fund is a much less expensive-and easier to operate-alternative to starting a private family foundation.

Many remember Roger as an enthusiastic and dedicated community servant and friend. Outside



Field of interest funds are used to fulfill grant requests submitted through the foundation's quarterly grant competition. A grant committee and the board of directors ensure these funds are used to support charitable organizations in La Crosse County whose work aligns with the purpose of each fund.

## FIELD OF INTEREST FUND SPOTLIGHT Fund for the Arts

The Fund for the Arts was initiated in 2021 by Sam Servais and Katie Berkedal to support the arts throughout La Crosse County. As a field of interest fund, the Fund for the Art's usage will be determined through a competitive grant program, and after thorough vetting by the board of directors.

Sam and Katie both grew up in La Crosse, and after spending some years away, returned to raise a family. They now have two middle school-aged children and have worked into their family values a commitment to giving back to the community. After Katie started working at the foundation as program director, she and Sam started talking about potentially starting a field of interest fund.

Since Sam has turned his passion as an artist into a career teaching art at Onalaska High School, having a fund that focused on the arts made sense. Sam is often commissioned to paint art pieces for friends and acquaintances. For Sam it's always been about creating art, not necessarily making money from it. By setting up this fund at the foundation, he's able to create art and put the earnings from his work towards this fund.

As Sam states, "To be honest, putting a price tag on my art is my least favorite part of the process. This is a way I can do what I love-create the actual piece of art-while letting the people that have commissioned the piece decide what they'd like to give to this fund. Then the funds will eventually filter back into our community through art." Talk about a full circle moment.

Just as in life, everyone has a different approach to art. It expresses individual creativity, and it helps to process big emotions, especially through trying times.

Agency funds are created by nonprofits, for nonprofits. Each year the nonprofit can choose whether or not to take a distribution from the fund. The La Crosse Community Foundation has built-in fiduciary oversight, which provides an added layer of protection for honoring the intended purpose of the fund. This is just one benefit of having an agency fund at a community foundation, rather than through another endowment vehicle.



## AGENCY FUND SPOTLIGHT Onalaska Education Foundation, Inc.

The Onalaska Education Foundation, Inc. was established in 1998 to strengthen community participation in Onalaska public and private schools and provide financial support for "extra" programs that inspire teachers and students to achieve educational excellence. In thoughtful consideration of the organization's longevity, they created an agency fund at La Crosse Community Foundation in 1999 to support ongoing operational expenses.

The mission of Onalaska Education Foundation, Inc. is "to support educators in their quest to develop innovative opportunities for students, promote the incorporation of emerging technologies within the curriculum, facilitate business and private sector contributions to our schools, and encourage outstanding academic achievement among all Onalaska students."

With operational support from their agency fund, Onalaska Education Foundation, Inc. can focus their energy on doing good work in Onalaska schools, and helping educators develop innovative practices to maximize opportunities for students.

Wayne and Joan Spieker Wojciechowski Memorial Fund

Wayne Wojciechowski established the Wayne and Joan Spieker Wojciechowski Memorial Fund in 2021 to honor the passing of his beloved wife, Joan. The fund is designated to provide financial support for the needs of St. Clare Health Mission of La Crosse upon Wayne's passing.

Joan was born in Kenosha and moved to La Crosse in 1971 to attend the University of Wisconsin - La Crosse. After graduating, she was hired as a social worker by Bethany Lutheran Homes on Cass Street, where she worked for 42 years. She retired in 2011 as the director of social services and admissions. As a true servant leader, Joan remained as an on-call social worker for the organization until 2017.

Wayne was born in Milwaukee and moved to La Crosse in 1978 after completing his graduate work in counseling to work at Viterbo in academic support services. After 33 years of service, he retired in 2011 as the assistant academic vice president. Wayne currently is part of the Coulee Chordsmen, the Retired and Senior Volunteer Program, and the Viterbo Ministry board.

Wayne and Joan married in 1979 and built a beautiful life together in La Crosse, or as Wayne describes it, "God's country." Wayne and Joan were prayer partners with the Franciscan Sisters of Perpetual Adoration (FSPA), and the spirit of St. Francis and

St. Clare played a large part in both of their lives.

The Wojciechowski's were able to see the beginnings of St. Clare Health Mission

when it was first established by Sr. LeClare Beres, FSPA, in 1992. Since its inception, services have expanded to provide free healthcare to any individual that lacks the resources needed to obtain healthcare.

Wayne states, "Not only does St. Clare Health Mission meet the basic human rights to healthcare, but it's also a response to gospel values. In the situations of people needing something, it calls to ask, what would Jesus, or St. Francis or St. Clare do?"

Wayne credits the current executive director of St. Clare Health Mission, Jason Larson, with the encouragement to start his bequest with the La Crosse Community Foundation. Jason had the foresight to realize the bigger impact the Wojciechowski's bequest could have on the community by being endowed as a fund with the foundation, rather than a one-time gift directly to St. Clare. After realizing this lasting impact, Wayne knew having this fund at La Crosse Community Foundation was the route to take.

Wayne shares, "La Crosse Community Foundation manages its donors' money well, they are a community-minded foundation that responds to the needs in La Crosse County to make it a better and safer community. 

Message from Chief Operating Officer Erin Belby, CPA

A community foundation is meant to be exactly what it states—a foundation, or a base upon which a structure, in this case the community, is supported. In these times, that definition holds true for the La Crosse Community Foundation.

For the past 91 years, the La Crosse community has been building its foundation through generous gifts to endowed funds. With guidance and oversight from our dedicated board or directors, we continue to ensure our funds are as impactful as possible. Our endowed funds are subject to a spend rate policy that aims to protect endowed assets, so they last in perpetuity while also providing smooth and predictable grantmaking distributions every year. This means that endowed funds can reliably support our community even through unpredictable economic and political times.

The La Crosse Community Foundation was built by endowed funds, but that does not mean we are not up to meeting the challenges of the moment. Over the past three decades, the foundation has partnered with local organizations and donors to raise and disburse funds to meet immediate needs through our un-endowed funds. These funds are for visionary projects like Trane All Abilities Park and unforeseen needs like pandemic response.

The balance between our endowed funds and unendowed funds creates a strong foundation that is both sturdy and unwavering, yet flexible and responsive. At the end of 2021, almost 90 percent of our assets were endowed or permanently restricted. This solid core of our foundation is what allows us the flexibility to address immediate needs through un-endowed funds with low or no administrative costs to the funds themselves.

We are built strong and lean. Our operating expenses are a little more than half as much as the average community foundation of comparable size. Our operating policies create an incredibly efficient structure that allows us to be nimble and responsive. This operating environment isn't something we created overnight, but rather something our predecessor board members and staff have crafted over decades. Our current team recognizes the diligence of our predecessors and commits itself every day to meeting the needs of our community and the expectations of our fundholders.
